

RECIDIVISM OF PAROLED SEX OFFENDERS—TEN (10) YEAR STUDY

The following figures on a ten-year California Department of Corrections and Rehabilitation (CDCR) follow-up study of the recidivism of 3,577 individuals convicted of a sex offense who were released from CDCR prisons in 1997 and followed until the end of 2007

NOTEWORTHY FINDINGS: The total number and % of sexual recidivists is lower than some might have believed. Most re-offenses and parole violations occur in the initial period of reentry after release. Sex offenders are more likely to commit some other type of offense than to commit a new sex offense. Although supervised intensely, sex offenders are returned to custody for parole violations at a lower rate than the average for all CDCR parolees (60-70%)

* All percentages are based upon the original total of 3,577 parolees released during 1997 (Since some had been returned to custody during the study period, not all of them continued to be at risk in the community. A significant number, however, were probably returned to custody for a parole violation and then released on parole again).
