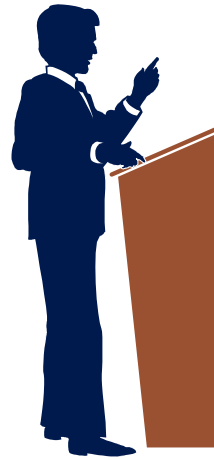


California Sexual Violent Predator Recidivism

An Empirical Statistic Report of Released Sex Offenders under California's Welfare & Institutions Code 6600

The following, an empirical study, pertains solely to the 6600 ^{1/} populations, individuals designated as Sexually Violent Predators (SVPs). Attached are Comparison Charts, Statistical Reports, and a complete listing of all persons released from state custody back to the community who have and have not participated in a treatment program. ^{2/} This study is updated on a quarterly basis in order to provide its readers with a current and accurate recidivism rate for SVPs and reflects factual numbers rather than statistical compilations as found in most published reports. The findings herein present a divergent view from the accepted norm – the belief that sex offenders will reoffend upon release – and documents that, if the current reoffense rates are correct, there is at least a **94% chance or higher** that a sex offender will successfully integrate back into society **without** reoffending.

The word “empirical”, as defined here, means: “Derived from experiment and observation rather than theory.” This study takes empirical data on SVPs released back to the community and presents the facts rather than the hype found in other studies. As more SVPs are released, this study will continue to add the empirical facts, regardless of the findings, to the already existing body of evidence that other studies have inflated or manipulated numbers to reach conclusions which are not supported by the available data. Accordingly, quarterly updates have been conducted which empirically show that recidivism rates of persons participating in SVP treatment programs stands at 2.6% with an average of 6.8% for those who did not participate in said treatment.

Currently, California mandates that all state evaluators utilize the Static 99 Assessment tool as the preferred predictor for sexual recidivism. This “tool” by Dr. R. Carl Hanson, Ph.D., in its original iteration, had a base recidivism rate of 51%. Subsequently, Dr. Hanson has repudiated his original findings and presented revised figures which tell a different story. In September 2008, Dr. Hansen presented facts which indicate a new base recidivism rate of approximately 26%, a significant difference from the past! This 25% difference strongly suggest that a large majority of persons identified as SVPs under the old Static 99 conscripts, would **not qualify under the new SVP criteria**. It should also be noted that Dr. Hanson’s original study group, conducted on sex offenders in Canada **who were not incarcerated**, failed to identify first time offenders from repeat offenders. Additionally, Dr. Hanson’s group contained all sex offender types ^{3/} – many of which are not included in the California SVP Act codified in the Welfare & Institution Codes.

These lower numbers have historical support. A report entitled, “Recidivism of Sex Offenders Released from Prison in 1994”, published by the U.S. Department of Justice, Bureau of Justice Statistics June 2002 ^{4/}, found that of 9,691 individuals studied, 3,395 from California, only **3.5%** of those released reoffended sexually within 3 years of their release. Subsequently, in October 2006, Dr. Jesus Padilla, Ph.D., a practicing psychologist employed by Atascadero State Hospital (ASH), ^{5/} conducted a study of sexual recidivism rates of 91 SVPs in treatment but who have not completed the prescribed treatment at ASH, later released, and found that only **3.4%** committed new sex offenses.

What is the difference of those who participate in treatment and those who choose not to? The table below will shed some light on the question, “Does Treatment really help?” For some, it’s a blessing, but for many others, it’s a nightmare, it may cause more harm than good. Comparing the numbers on the table below, one can see there is little difference 4.2% between those who have reoffended sexually; about 9.5% for those who have reoffended non-sexually. What is really alarming is that of the number who have participated in the treatment program, there is a 2/3rds chance of violating a condition of either Parole or Liberty release agreements and being returned to the State Hospital for additional treatment.

Please keep in mind that the data will change from quarter to quarter. As more offenders are released new data is added to this report. Changes in percentages and the actual numbers will either increase or decrease, and for this reason it’s important that you have the most current information possible and especially if you are a defense attorney. This information is used more and more by defense attorneys throughout California and many evaluators are familiar with this report and the different reports being generated concerning sexual recidivism.

The following are of the Reports attached:

Report 1: *Statistical Report of W&I 6600s Released Listing for 2010*

This report indicates 15 Reference Categories in which the released individual is placed. The totals within each category can either go up or down depending on whether or not the individual reoffends. If the individual reoffends, he will be deducted from his original Reference Category and placed into either category 14, reoffended **non**-sexually or category 15, reoffended sexually. This report also contains information on how many individuals were released within each year and released by county in addition to other information listed within the report located at bottom left corner.

Report 2: *Comparison Chart of 6600s Who Have & Have Not Reoffended*

This chart shows the differences between those who have and have not reoffended over the past **14.5** years. This chart shows that those who reoffend sexually are very small in comparison to those who are still living offense free. Please note that the totals are cumulative.

Report 3: *Comparison Chart "Percentage of Sexual Reoffense"*

This chart indicates a narrow corridor of reoffense from 5.5% to 9.5% with an average of 7.2% recidivism over a **14.5** year span. While some percentages may fall outside the corridor, these exceptions do not deter from the validity of the corridor. This gives rise to the thought, if correct, that there is at least a 94% or higher chance of a sex offender being successfully integrated back into society.

Report 4: *Comparison Chart of the Total Number Released & Reoffended Per Year*

This is a comparison chart of those who have and have not reoffended and the total number released per year. The individual totals are not reflective as to how many reoffended either sexually or non sexually in relation to the total released per year. Rather they are of the whole of those who have been released.

Report 5: *Released By County*

This report is broken down by counties. It indicates how many were released under each reference category. Additionally, it indicates whether or not the released reoffended inside or outside of State Hospital custody. (page 2 of report, right hand side)

Report 6: *Released Listing of W&I 6600s Who Have Attended Treatment*

This report lists all released individuals who have attended any of the phase treatment program, in which phase of the treatment they were in when released and whether or not they reoffended. Currently the reoffense rate indicates 2.6% reoffended sexually after participating in the treatment program. Additionally, this report also indicates how many individuals are under Liberty Treatment Program, by what means they obtained their outpatient treatment and those who have been discharged from the Liberty treatment program.

Report 7: *Treatment Report – Part 2*

This report outlines the treatment modality currently in place. The lack of oversight of the treatment or of the treatment facilitators and highlights on other subjects such as “New Treatment Modality on the Horizon”, “DMH Fights against Any Sex Offender Being Released”, Miss Use of the Stable 2007”, “Life without Hope”, “Do No Harm”, and “Unsafe Levels of Stress”.

Report 8: *To Prison Report*

This report contains all those who have been sent to prison and the reasons for which they were sent. Additional, this report also lists those who have violated parole while at Atascadero or Coalinga State Hospital.

Report 9: *Death Report*

This listing is of all who have died and the reason for their death if known while in custody.

Report 10: *Released Listing For 6600s*

This listing is of all who have been released and the reason for their release. It is sorted by the release date of the released individual and includes the reference category in which they are placed, their county of commitment and whether or not they reoffended. This listing is considered **raw data** in which all other reports are derived from.

1. **This Report has been updated with the most current information. Previous publications should be disposed of as corrections have been made making this report the most accurate of all previous reports.**
2. **New information and reports have been included in this publication. Statistical report. This New information concerning the treatment program at Coalinga State Hospital can be found in Report #8 "Treatment Report – Part 2.**

¹ In January of 1996, AB 888 became law and was informally known as the Sexually Violent Predator Act. This SVP Act was codified in the California Welfare and Institution Codes starting at section 6600. Any person being reviewed from or factually found to meet the conditions of WIC §6600, are all grouped under the heading of sexually violent predator.

² "Sex Offender Commitment Program" (SOCP) is California's current iteration of a treatment program. There have been at least three prior attempts at "treating" sex offenders including the Mentally Disordered Sex Offender (MDSO) program and the Sex Offender Treatment Program (SOTP). Each of these were found to be illegal or unconstitutional. The current SOCP has been designated an "experiment" because no medical authority or organization recognizes the modality of treatment as therapeutic or effective. Actual numbers of SVPs released into the community who have not participated in "treatment" have done as well or better than those in treatment.

³ The original WIC §6600 et. seq., (Sexually Violent Predator Act) did not include such "types" as incest, voyeurism, rapists, or exhibitionists. Unfortunately, in September of 2006, California voters passed Proposition 83 which now includes many of the latter and add some of additional crimes not identified by the DSM-IV-TR. Most of the latest additions are not supported by the American Psychiatric Association or its members.

Offense definitions and other methodological details are available in the BJS publication *Recidivism of Prisoners Released in 1994*, NCJ 193427, June 2002.

⁵ Atascadero State Hospital's sex offender programs have, at any given time, held that highest number of persons accused of or convicted of sex crimes in the world. At the time of Dr. Padilla's research, ASH held almost 500 men accused of being sex offenders. Today, all those individuals have been moved to Coalinga State Hospital in Coalinga, California, and has surpassed 900 men being held under the SVP Act. Dr. Padilla's research was ordered by Napa Superior Court to provide information to Defense Attorney, Jim McEntee (People v. David Gould - Case#: 08CRSP678844) indicated by a ASH Memo to the Napa Superior Court dated October 10, 2006. Dr. Padilla's testimony was given on March 25, 2008 at which time his findings became officially published.

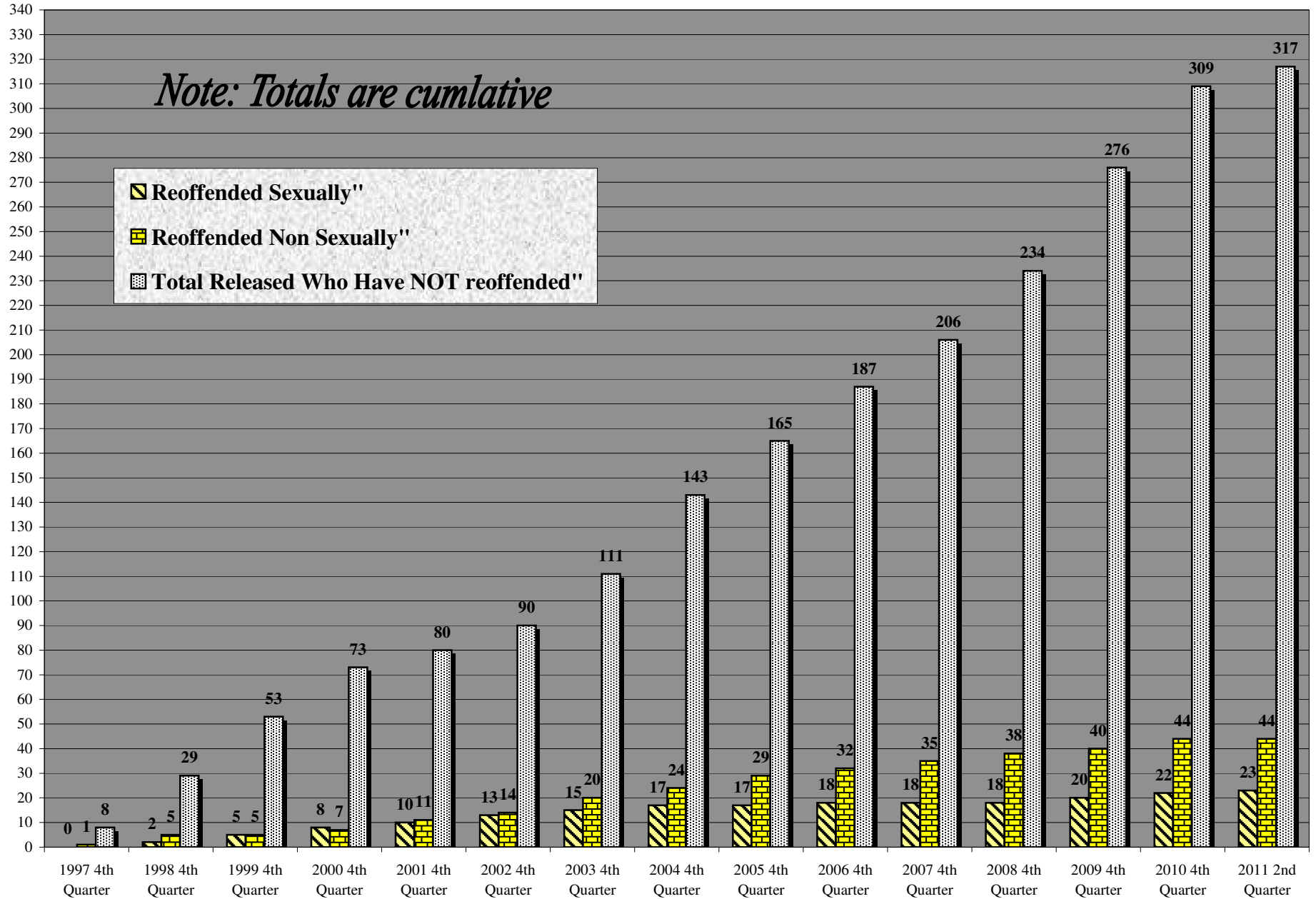

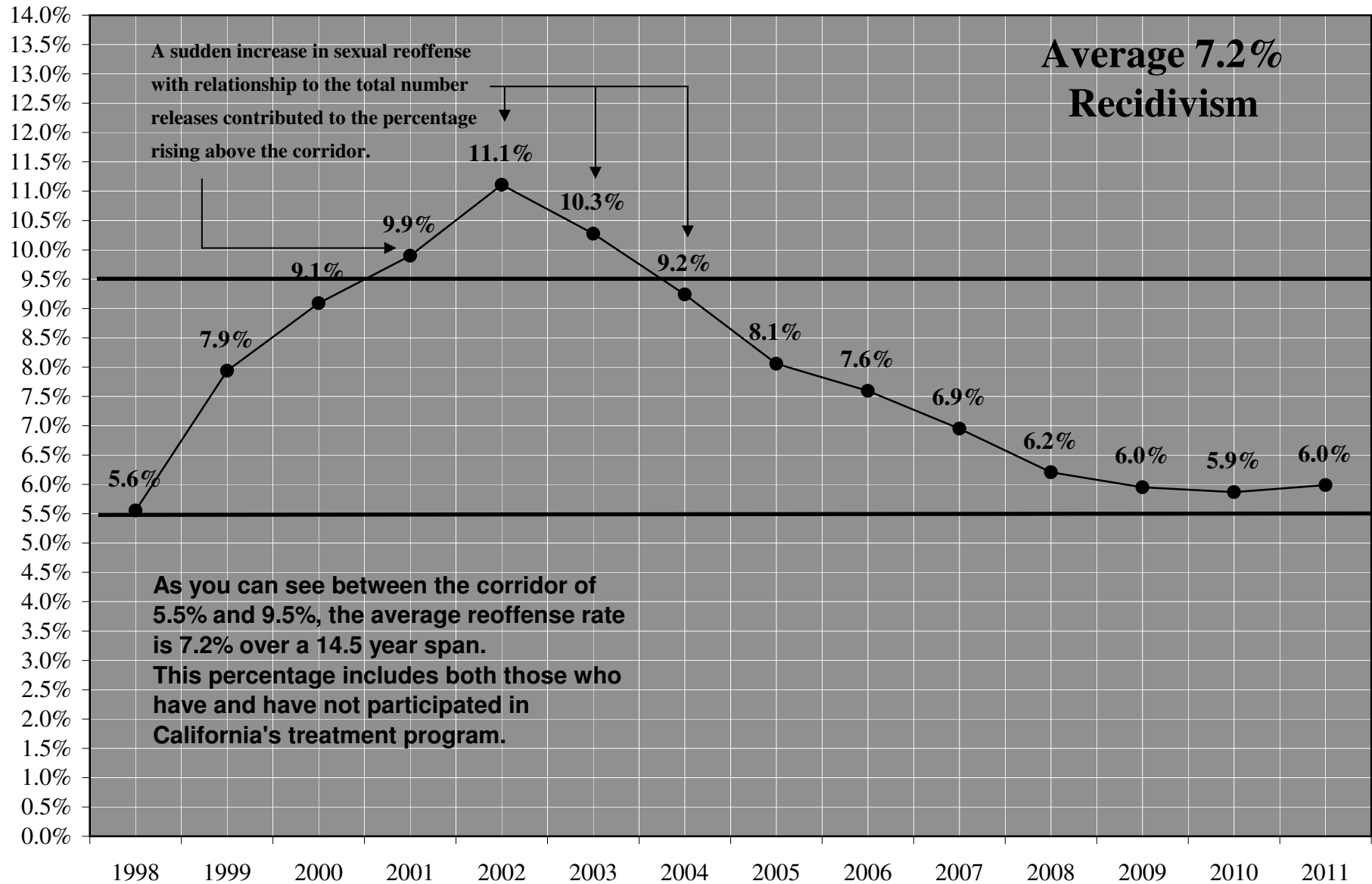

Comparison Chart of 6600s Who Have & Have Not Reoffended

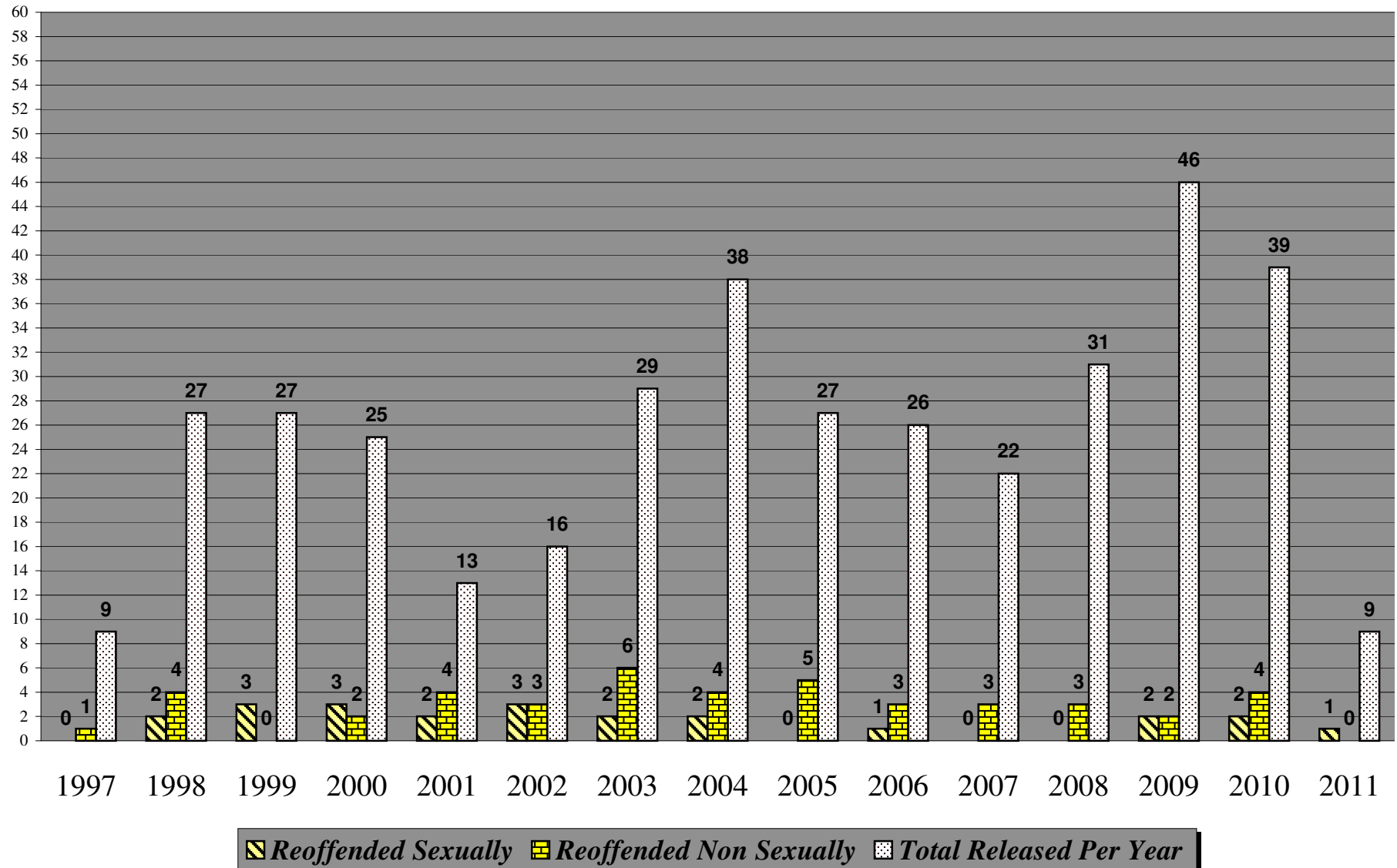

Treatment Report – Part 2

The table at the right reflects the current number of Sex Offender Treatment Program (SOTP) “Phase” groups available and staffed for patient participation. The actual number of patients participating is unpublished. It is safe to assume that there are approximately 8 to 10 participants in each of the Phase II and Phase III classes. Phase IV & V have never had more than 5 patients (run concurrently) and Phase I Tutorial patients are not counted as actual SOTP participants as they have yet to sign *The Contract*.

NOTE: For reasons of treatment confidentiality a listing of patients currently participating in treatment is not maintained.

To the average person this listing at the right can be confusing but for many who are familiar with the treatment process it will be recognized as what treatment groups are available for patient participation.

For those not familiar with the treatment program at Coalinga State Hospital the following is provided as a synoptic overview of the treatment currently being offered.

TREATMENT OVERVIEW

PHASE I: *An Introduction to Sex Offender Treatment Program (SOTP).* Colloquially called *The Phases*, Phase I begins as a two part program: Part 1 addresses the SVP Law and its ramifications. Part 2 presents the patient with actual concepts used and discussed in Phase II including discussions on a person’s history, Phase presentation preparation, and sample Phase Lay-Outs, Victim Charts, et cetera.

PHASE II: *Introduction to Cognitive-Behavioral Therapy* and actual participation in this therapy with an emphasis of personal application. The focus is placed on the patient’s personal offense history addressing the issues which motivated the patient to manifest his negative behavior. Additionally, four modules are covered: 1) Lay-Out; 2) Relapse Prevention; 3) Cognitive Distortions; 4) Victim Awareness; and, 5) Autobiography.

PHASE III: Known as the *Skills Application* portion of the SOTP, Phase III is designed to help patients begin applying in their lives the skills obtained in Phase II. Self critique of daily practical application of Phase II skills through a process called journaling is the cornerstone of this treatment. The following modules are covered in Phase III: (1) Layouts pt. II; (2) Journals and Logs; (3) Cognitive Distortions pt. II; (4) Relapse Prevention pt. II; and, (5) Victim Awareness pt. II.

PHASE IV: *Skills Transition - Module: Release Planning:* Topic: CONREP, (Conditional Release Program) Terms and Conditions for release. The Goal: To have group members become familiar with (1) Terms and conditions of Outpatient Treatment that might apply to them, and (2) know how those terms and conditions are designed to protect the community and prevent relapse on the part of the patient client.

PHASE V: *Out Patient Treatment*: The patient client, when staffed to Phase V, is [supposed to be] released back into the community under the direct oversight, care and custody of Liberty Corporation which has a contract with the state to run the Conditional Release Program (CONREP). Presently, CONREP is costing the taxpayers an additional \$1,000,000.^{En 1} per year per outpatient client. Of those patients *staffed* to Phase V, it has taken no less than 2 years and up to 5 years for Liberty Corporation to find housing and actually *place* the patient back into society. Currently, five CSH patients have been staffed to Phase V with two of the five patients being found *unsuitable for release* by state evaluators. It appears that the other three may face the same prospect.^{En 1} In simple terms, **completion of SOTP is no guarantee that a patient will ever be released!** The Problem: There appears to be no faith in the treatment modality and its efficacy by DMH managerial staff or CSH clinician/facilitators *and* an abject lack of oversight of the phase facilitators which leads to inconsistencies from treatment group to treatment group. This is unconscionable.

NO Oversight of the Treatment or Treatment Facilitators

Specifically: Coalinga State Hospital does not have an oversight committee of *trained professionals*^{En 2} to review and assess clinician/facilitators' teaching capabilities *and* how and what they teach. Compounding this is a lack of a training syllabus. Consider the following: CSH is the worlds' largest sex offender treatment program. Yet no studies have been conducted to determine the efficacy of the treatment program or to assess the effectiveness of each facilitator. Part of the problem has been that since its inception, CSH has had great difficulty in attracting and keeping licensed clinicians. At any given time, over 65 percent of those holding Ph.D.'s are unlicensed psychologists. They are technically doing their 2,000 hours of internship ostensibly under the critical eye of a licensed professional. Unfortunately, CSH has been forced to place numerous unlicensed psychologists under the supervision of a very few licensed and qualified psychologists wherein the intern has little or no oversight. A fact, little known and/or ignored by DMH/CSH: unlicensed Ph.D. interns are not psychologists and cannot claim that title. However, almost every working day an unlicensed psychologist signs Wellness & Recover Team Reports, reports which are court documents, and can only be signed by a licensed psychologist. Furthermore, they are unable to make a diagnosis of a patient client's mental disorder *without* the oversight of their sponsor. Yet CSH unlicensed clinicians do so on a regular basis.

Without a coherent treatment policy CSH senior clinicians assume that a person holding a Ph.D. in psychology and/or Master's Degree in Social Work, (M.S.W.), is automatically qualified as an expert in "treatment." While this assumption by senior staff is axiomatic—Ph.D./M.S.W. well qualified and smart—the fact remains that sex offender treatment is poorly understood and there is little if any empirical proof that SOTP as practiced is efficacious. Considering the number of Phase V patient clients *violated* while back in society under Liberty's

CONREP there is a mounting body of evidence that SOTP has been, and continues to be, an abject failure.^{En 3}

Additionally, with little or no oversight from phase group to phase group, there are marked differences in the expectations as to what is taught and how what is taught is clinically measured. An example of this problem: Patient A has been recommended for *staffing* from Phase II to Phase III. Prior to his staffing date he is sent out to court. Upon his return he is placed in a different Phase II group where the facilitator determines that Patient A really is not ready to be staffed based on his or her criteria and must now redo his Phase II material. This is not rhetoric but fact as it has happened numerous times.

Each treatment group is independent of the other and likewise each treatment facilitator conducts his or her group independent from the other treatment group. Hence, if either the patient or clinician moves to another group, treatment effectively starts over. Thus, the chance of an SOTP patient participant ever being staffed to Phase V is infinitesimally small. As of this quarter's report, only seventeen (17) men have reached Phase V from the pool of phase participants. Of the seventeen Phase V patients, five (5) violated the conditions of CONREP and have been returned to ASH or CSH. And, as shown directly opposite on this page, of the five SOTP participants staffed to Phase V, two have been denied release by the courts as *unsuitable for release* and the other three are awaiting placement by Liberty, a process that takes years! And, a statistically significant number of licensed psychologists and social workers have refused to participate as facilitators in SOTP treatment and/or have tendered their resignation as CSH policy violates their professional ethics. A glaring example of CSH's contradiction of policy was the termination of Dr. Greta Todd, Psy.D., not because she was incompetent but because she was too competent: she did her job to the highest professional standards and held her coworkers accountable. Dr. Todd's work ethic and moral compass was such that it constituted a threat to those who put their job over professional integrity.

New Treatment Modality on the Horizon

If one concedes that the SOTP modality of treatment lacks a solid, peer reviewed and recognized foundation and structure—DMH appears to be in this camp with the advent of a new patient strength oriented treatment program—and patient client participants have limited chance (hope) of every being *staffed* to Phase V, then why should a CSH patient even consider participating in SOTP? The California Legislature made clear in the legislative notes that treatment would take approximately two years! Now, fifteen (15) years later and no patient participant every released pursuant to WIC § 6605 and only seventeen Phase V patients released under WIC § 6608, it is clear that something is terrible wrong.

The *vast* majority of patient client participants have been in Phase II for 8 to 10 years with little or no hope of ever being staffed to Phase III. This strongly suggests that: (a) the clinician/facilitator is grossly incompetent, (b) the patient client is an inherent failure, (c) the patient client does not want to progress, and/or (d) a combination of all of the above. Regardless, the clinician/facilitator has a moral and fiduciary responsibility to provide prompt, efficacious treatment which offers real hope of meaningful change

leading to release from SVP servitude. This is effectively not happening.

DMH Fights Against Any Sex-Offender Being Released

Should the patient client actually be staffed to Phase V, Out-Patient treatment, he is confronted with the stark realization that the California Department of Mental Health has never, ever, recommended a patient for release under Welfare & Institutions Code §6605. In fact, DMH has never, ever, recommended a patient released pursuant to the law but instead fought the release of each and every Phase V client who has filed for his release under WIC § 6608! This too is unconscionable and strongly suggests that DMH and CSH do not believe or have faith in the SOTP process.

Miss Use of the Stable 2007[©]

In 2007, R. Karl Hansen, Ph.D., et al., introduced the Stable 2007[©]. When administered in conjunction with the Static 99[©] or Static 2002[©] Hansen and his research team were able to determine *dynamic* risk factors of men on parole or probation in Canada. It was well understood that all risk factors are always subject to change and through a carefully worded and administered questionnaire coupled with empirical observation by the parole officer, changes in their clients risk factors were documented as a dataset and those changes strongly indicated which of the parole/probation clients were most likely to reoffend. Thus the Stable 2007[©] became a strong tool in determining recidivism in a highly controlled study.

Unfortunately, the senior clinicians at CSH took the Stable 2007[©] and its attendant questionnaire and directed CSH Unit Social Workers to review and modify Dr. Hansen's questionnaire and administer it to their patient clients on the unit. This need to *modify* was based on the wording of some of the questions which CSH determined were not relevant or germane. This truncating process has now led to some very unfortunate consequences.

First, there is an inconsistency in the questions asked from social worker to social worker.

Second, the data collected is suspect as the questionnaires are not consistent.

Third, the questionnaires as formulated are not peer reviewed.

Forth, the resultant dataset for each patient client, collected once—not over a period of six to nine months and in some cases over several years—as done in Canada, immediately leads to the social worker finding and adding new barriers to discharge.

It should be noted that barriers to discharge are identified during the state evaluation process and each *barrier* takes several years to “correct” through WRP Team recommended treatment. Now, years into treatment, new barriers to discharge are being *found* and the patient's chance of being staffed to the next level has markedly decreased. This begs the question: If these *new* dynamic risk factors exist, why were

they not identified previously and, were the original evaluators incompetent and/or are the current social workers, not trained or qualified in assessing the dataset obtained via the Stable 2007[©] making a rush to judgment concerning the patient's responses to questions, questions and limited dataset not peer reviewed, which have now led to these new barriers to discharge—not dynamic risk factors.

Life without Hope

Now, with the advent of all the patient clients facing an *indefinite* commitment to the Department of Mental Health by California Courts, there is no guarantee that even those *staffed* to Phase V will ever be released. Those patients already identified and committed as SVP's with an indefinite commitment term have their lives in the hands' of alleged professionals who, at best, have little or no clinical training or understanding of true sex offender treatment. There is a bad joke going around CSH among the *inmate* body “People are dying to get out of here, literally.” And, with the cost of care, custody and treatment now exceeding \$240,000.⁰⁰ per patient per year, where will it end? ^{En 4} Review of the dataset above indicates that DEATH is the most likely means of release from DMH.

“Do No Harm”

Finally, the most important concern for all is the state evaluators' blatant disregard of their own ethical and moral obligation as a physiologist: “Do No Harm”. Each evaluation conducted by state evaluators—it has been stated that the American Psychiatric Association (APA) will not permit its Board Certified members to participate in any phase of the SVP Act—violates the most basic ethical requirement wherein the evaluator identifies a patient's current signs and symptoms, a mandatory requisite by the APA and reiterated in the DSM-IV-TR, and they further fail to identify the patients severity specifiers. This constitutes a blatant disregard for the DSM-IV-TR, the American Psychiatric Association manual they claim to rely upon to supposedly determine a patient's qualifying mental disorder.

“Unsafe Levels of Stress”

Over the past year, the patients at CSH have exhibited both the signs and symptoms of high stress. The number of men returning from court with indefinite commitments, the new implementation of *alleged* safety and security codes by DMH, not to mention the diminished quality and quantity of the food—Prison Industry Authority (PIA) has become the vendor of choice for many foods—the patient population is being inundated with negatives with little or no means to vent their frustrations. On top of this, at least one California Superior Court is taking the stand that a CSH patient staffed for Phase V, but not recommended for release pursuant to WIC § 6605, will not be considered for supervised release under the provisions of WIC § 6608. Why? Because, it's the law! While this writer has been careful not to prognosticate—there are state evaluators to do that—I would suggest that the coming year does not bode well for interpersonal relations between CSH patients and staff.

- ¹ Technically, when a patient completes the SOTP and is *staffed* to Phase V, Welfare and Institutions Codes mandate that the Department of Mental Health/Coalinga State Hospital recommend the patient client released pursuant to WIC § 6605. This has never happened. Instead, the staffed patient must file under WIC § 6608, wherein he petitions the court—and must prove—that he has so changed and he no longer constitutes a threat and danger to himself or others. However, the California Department of Mental Health, Atascadero State Hospital, Coalinga State Hospital and Liberty Corporation *have gone to court and fought the release of each and every Phase V client who filed under WIC § 6608*. It goes without saying that DMH and Liberty do not trust the very treatment program they have set in place. Furthermore, SOTP Phase Facilitators, when subpoenaed to court to testify become *hostile witnesses* for the defense and will only discuss what a patient client has completed, e.g., what classes he took, et cetera. When these same professional psychologist facilitators are asked whether a patient client of theirs' constitutes a threat or danger to himself or others they state "No one can make that determination." Of course, that is exactly what the state evaluators did during the WIC §§ 6602/6604 commitment proceedings and , determined that the then Department of Corrections & Rehabilitation inmate will pose a threat and danger to others.
- ² The pathology or thinking process of sex offenders is little understood. There are few *true experts* in the field of sex therapy and the majority of those clinicians recognized as experts—board certified psychiatrists and psychologists—have criticized the SVP laws as nothing more than a "smoke and mirror game" to keep sex offenders locked up indefinitely. This is most evident at CSH where there are two diverse schools of thought concerning sex offenders: One group of clinicians hold sex offenders can never make *meaningful* change and the diametrically opposite group of clinicians who believe sex offenders can change. It has been suggested that academia has failed, and failed miserably, to conduct long term studies as to modalities of treatment and which treatment modalities work. At CSH if one has a doctorate in psychology or a master's in social work, he or she is passed off as an expert.
- ³ CSH has been abuzz with the news that SOTP is being replaced with a new patient client *strength based* treatment program. There is more than just smoke as phase participants have been informed of the change and many clinician/phase facilitators have admitted taking training for the program. This strongly suggests that DMH has looked at the failure rate of its patient client phase participants, assessed the numbers of those released sans phase treatment who have never reoffended, and have had an epiphany fostered upon them: Change or perish. This is not rhetoric. As more of the CSH patient cliental recognize that there is diminishing hope of release through the SOTP they will no longer participate. This is already beginning to happen.
- ⁴ The math is staggering. Bases on cost of care, custody and treatment at \$ 240,000.⁰⁰ per patient per year times approximately 850 patient clients is a whopping \$204,000,000.⁰⁰ placed on the shoulders of the taxpayer. Texas, a state long known for its attitude of being *tough on crime*, took all of its SVPs and placed them on outpatient treatment! Texas claims to use the same evaluation paradigm as California yet each of those men designated SVP in the State of Texas are out living in the community and, in most cases, as productive members of society albeit on a modified CONREP oversight. As of this report, none has committed a new sex offense. None!
